

London Landmarks Half Marathon 2025 Terms & Conditions

If we offer you a charity place, you will have one month from the date of the place being offered (or one month from the announcement of the ballot results) to pay your registration fee and you will be required to sign to confirm that you have read Coram's Terms and Conditions. Until payment is received and the Terms and Conditions are signed, your place is not secured and could be offered to other runners on the waiting list.

All successful applicants must pay a £25 registration fee (non-refundable) for their place and commit to fundraising a minimum of £350 excluding gift aid. Participants will receive a Coram running vest or top prior to the event.

Registration

- In order to be offered a London Landmarks Half Marathon (LLHM) place, the runner must return a signed copy of the application and terms and conditions form.
- In order to confirm their LLHM charity place, the runner must pay the £25 registration fee (non-refundable) within one month of receiving the offered place. This can be paid via cheque or BACS Coram will provide relevant details.
- You understand that you must register through the LLHM's Online Charity Management System within the deadlines provided

Sponsorship, donations and payment terms

- You understand that Coram incurs costs for each charity place in the LLHM. We set our budgets and plan the work
 we do with children, young people and families on the funds received from our participants raising their sponsorship.
 For this reason, it is vital that you raise the funds that you have committed to when taking up your charity place
 with us.
- You agree that Gift Aid payments cannot count towards the fundraising pledge, and instead will be considered as over and above the pledged fundraising total
- If the sum of £350 has not been raised by Sunday 6th April 2025 the date of the run you will have one month after the event to raise the money or agree to pay the remainder from your own personal funds within one month of this date or in instalments to be agreed in writing with Coram. You understand that Coram reserves the right to request the payment from you if you have not met the fundraising target.

Cancellations, withdrawals and refusals

- No refunds will be given to the Charity Partner if it is unable to fill Charity Places and charity places that are not filled by the Charity Partner cannot be rolled over to the following year
- You understand that if you withdraw you cannot defer your charity place and will have to reapply if you are interested in taking part in any future LLHM events.
- If you withdraw from the run, you understand that any monies raised is not refundable
- If you withdraw after the LLHM's Online Charity Management System closes Coram will be unable add a replacement runner and the place will go unused. As result, we will require you to pay 75% of the fundraising target to Coram by Sunday 6th April, the day of the LLHM event.
