Adoption and Special Guardianship Quarterly Data Collection

Headline Measures: Q3 2024/25

March 2025

Note: The Department for Education's annual figures on adoptions and timeliness for children who have been adopted are published in the <u>Children looked after in England including adoption</u> SFR. This is the most robust source of information on adoption.

CHILDREN

The numbers of best interest decisions for children continue to decline. Overall, less children are being matched and placed with adopters, and the numbers of children waiting with a PO continue to rise. Timeliness for children is slowing and more children are waiting longer to be placed with an adoptive family.


In Q3 2024/25 there were:

- 830 Agency Decision Maker decisions, a decrease of 11% (100n) from Q2 2024/25, and a decrease of 19% (190n) when compared to Q3 2023/24
- 680 Placement Orders granted, a decrease of 16% (130n) from Q2 2024/25, and a decrease of 19% (160n) when compared to Q3 2023/24






- 550 ADM reversals in total for Q1, Q2 and Q3, 71% of the total for 2023/24
- 27% of reversals were due to 'Child's needs changed', 30% 'Court did not make a PO', 11% 'Adopters cannot be found', and 31% were due to 'Any other reason'




The numbers of Adoption Orders granted decreased, and the number of Special Guardianship Orders granted increased when compared to the last guarter. Total permanence was slightly lower when compared to last guarter.

In Q3 2024/25 there were:

- 680 Adoption Orders granted, a decrease of 15% (120n) from Q2 2024/25, and a decrease of 7% (50n) when compared to Q3 2023/24
- 990 Special Guardianship Orders granted, a decrease of 9% (100n) from Q2 2024/25, and the same when compared to Q3 2023/24
- 1670 total permanence orders granted (AOs & SGOs), a decrease of 12% (220n) from Q2 2024/25, and a decrease of 3% (50n) when compared to Q3 2023/24
- SGOs accounted for 59% of all permanence, an increase of 1 percentage point when compared to 2023/24
- 420 children were placed in an FFA/CP arrangement in Q1, Q2 and Q3, 76% of the total for 2023/24




The number of children waiting with a Placement Order, and waiting longer has increased.



In Q3 2024/25 there were:

- 2820 children with a PO waiting to be placed, an increase of 2% (50n) from Q2 2024/25
- 1410 children with a PO waiting to be placed 18+ months since entering care, an increase of 7% (90n) from Q2 2024/25
- 50% of children with a PO have been waiting to be placed 18+ months since entering care
- 740 children with a PO waiting to be matched 12+ months since grant of PO, an increase of 16% (100n) from Q2 2024/25
- 26% of children with a PO have been waiting to be matched 12+ months since grant of PO
- 360 children with a PO waiting to be matched 18+ months since grant of PO, an increase of 24% (70n) from Q2 2024/25
- 13% of children with a PO have been waiting to be matched 18+ months since grant of PO

The number of children matched and placed with an adoptive family has decreased this quarter.



In Q3 2024/25 there were:

- **670** children matched with an adoptive family, a decrease of **4%** (**30n**) from Q2 2024/25, and a decrease of **8%** (**60n**) when compared to Q3 2023/24
- 600 children placed with an adoptive family, a decrease of 14% (100n) from Q2 2024/25, and a decrease of 17% (120n) when compared to Q3 2023/24


Timeliness has improved for some children and slowed for others. In Q3 2024/25:

- The average number of days spent waiting to be placed with Placement Order since entering care was **641 days**, an increase of **26 days** from Q2 2024/25
- Scorecard Indicator A10 (average number of days between a child entering care and moving in with its adoptive family adjusted for foster care adoptions) was **483 days**, a decrease of **1 day** from Q2 2024/25
- Scorecard Indicator A2 (average time between an LA receiving court authority to place a child and deciding on a match to an adoptive family) was **206 days**, an increase of **6 days** from Q2 2024/25
- Scorecard Indicator A20 (average time between a child entering care and an LA receiving court authority to place a child) was **355** days, a decrease of **9 days** from Q2 2024/25




For the first three quarters of 2024/25 there were:


- 1050 children with HTP characteristics adopted, 46% of all children adopted
- **1690** children with HTP characteristics waiting with a PO, **60%** of all children waiting with a PO
- **1020** children with HTP characteristics waiting with a PO 18+ months since entering care, **72%** of all children waiting with a PO 18+ months since entering care
- **560** children with HTP characteristics waiting 12+ months since grant of PO, **76%** of all children waiting 12+ months since grant of PO
- **300** children with HTP characteristics waiting 18+ months since grant of PO, **83%** of all children waiting 18+ months since grant of PO

The charts below give a breakdown of the number of children waiting with a PO, and adopted by characteristics.



In Q3 2024/25 there were

- Children who were aged under 5, female and not from an Ethnic Minority (excludes White minorities) background continue to be more likely to be adopted and less likely to be waiting with a PO
- Children aged over 5, male, from an Ethnic Minority (excludes White minorities) background, with a disability and in a sibling group continue to be more likely to be waiting with a PO and less likely to be adopted

NB: "Harder to place" is defined as a child who is any of the following: 5 years or over, with an Ethnic Minority (excludes White minorities) background, disabled, or part of a sibling group. Children with more than one harder to place characteristic will be counted in each characteristic.

CHILDREN'S TIMELINESS BY CHARACTERISTIC

In 2024/25, the average time from entry into care to waiting with a PO as at Q3 for all children was 641 days, 19 days longer than Q2 2024/25. Children aged 5 year and over waited the longest; 926 days, followed by children with a disability: 833 days, and Ethnic Minority children: 737 days.

The average time from grant of PO and waiting as at Q3 for all children was 288 days, 21 days longer than Q2 2024/25. Children aged 5 year and over waited the longest since grant of PO; 486 days, followed by children with a disability: 448 days, and Ethnic Minority children: 345 days.

The average time from entry into care to adoption for all children was 838 days, 3 days less than Q2 2024/25. Children aged 5 year and over had the longest journey to adoption; **1258** days, followed by children with a disability: **1128** days, and children in a sibling group: **971** days.



SPECIAL GUARDIANSHIP ORDERS


The number of Special Guardianship Orders granted in Q3 2024/25 decreased when compared to the last quarter. More children leave care with an SGO than an adoption order, with SGOs accounting for **59%** of all permanence.

In Q3 2024/25, there were:

- 990 SGOs granted, a decrease of 9% (100n) from Q2 2024/25, and the same when compared to Q3 2023/24
- 52% of the children were male, 48% female, 3% had a disability, 20% were from an Ethnic Minority (excluding White minorities), and 44% were in a sibling group




Children aged 1 to 4 are the largest group of children who leave care with an SGO (35%), followed by children aged 5 to 9 (27%)




 20% of SGOs were granted for children from an Ethnic Minority (excludes White minorities, with children with a Mixed Ethnicity are the biggest represented Ethnic Minority

- Children not in a sibling group continue to be the largest group of children who leave care with an SGO (54%), followed by children in a sibling group of 2 (27%)




- Grandparents are the largest represented group of Special Guardians, with **51%** of SGOs granted to grandparents, followed by other family relatives **(34%)**





Special Guardians aged 50 to 59 are the largest represented age group (30%), followed by and special guardians aged 40 to 49 (25%)




ADOPTERS


Adopter recruitment continues to decline, reducing the number of available approved adoptive families to be matched with the children waiting with a PO.

In Q3 2024/25 there were:

- 740 Registrations, a decrease of 3% (20n) from Q2 2024/25, and a decrease of 4% (30n) when compared to Q3 2023/24
- 580 Approvals, the same as Q2 2024/25, and an increase of 4% (20n) when compared to Q3 2023/24




- **2140** Prospective adoptive families not yet approved, a decrease of **3%** (*60n*) from Q2 2024/25
- **1540** Approved adoptive families waiting to be matched, an increase of **1%** (*10n*) from Q2 2024/25
- 190 approved adopters withdrew from the process after approval in Q1, Q2 and Q3, 56% of the total for 2023/24



The number of adopters being matched with a child, and having a child placed with them were lower this quarter.

In Q3 2024/25 there were:


- 530 Adoptive families matched to children, a decrease of 10% (60n) from Q2 2024/25, and a decrease of 13% (80n) when compared to Q3 2023/24
- 490 Adoptive families with a child placed, a decrease of 14% (80n) from Q2 2024/25, and a decrease of 17% (100n) when compared to Q3 2023/24



A higher proportion of adopters were approved within 6 months of registrations, and the same proportion of adopters were matched within 3 months of approval.

In Q3 2024/25 there were

- **24%** of adoptive families were approved within 6 months of registration, an increase of **1** percentage point when compared to Q2 2024/25
- **23%** of approved adoptive families had a child matched with them within 3 months of approval, the same when compared to Q2 2024/25



There has been a decrease in the proportion of VAA placements and placements to other LAs.


In Q3 2024/25:

- 79% of placements were provided by LAs themselves (via their RAAs)
- **7%** of placements were provided by other LAs (other RAAs)
- **14%** of placements were provided by VAAs



SUFFICIENCY OF ADOPTERS

Adopter Recruitment is declining, reducing the number of approved adopters available for the children waiting with a PO. This quarter there has been a decrease in adopter registrations and prospective adopters not yet approved. Adopter approvals have remained at the same level as last quarter, and there has been a small increased in the number of adopters approved and waiting.



Adopter sufficiency continues to decline, with more children waiting with a PO to be placed with a family than approved adopters waiting. There are more POs granted each quarter than adopters approved, resulting in a higher number of children reaching the matching stage compared to adopters.



In Q3 2024/25 there were:

- 680 POs granted, and 490 adopter approvals; a gap of 190
- **2820** children waiting with a PO not yet placed, and **1540** approved adopters waiting for a child to be placed; a gap of **1280**

Comparison of the family finding status for all children and all adopters waiting show that there are:

- 1750 children with active family finding
- **1340** adopter families need (based on the number of single children and sibling groups waiting to be placed)
- 720 adopter families with active family finding
- 620 shortfall of adopter families
- 54% adopter sufficiency (proportion of families available for families needed)

DATA SOURCES

ASG Quarterly Data Collection

In quarter 3 2024/25 the response rate from local authorities for the child level section was 100%, and the adopter level sections was 100%. The response rate for the adopter level section from Voluntary Adoption Agencies was 100%. Therefore, national and regional figures on adoptions and adopters do not include estimates made for non-responses.

SSDA 903 Data Collection

Local authorities provide data on their looked after children using the SSDA903 collection. Data are collected from all local authorities. The information is collected at child level and includes information about the child's characteristics and their dates for each stage of the care process, including adoption. The data goes through thorough quality assurance and local authorities are able to update their historic data annually. We therefore view this as the most robust source of information on adoption. It is used to produce the <u>Children looked after in England including adoption</u> (SFR). The most recent data covers the year ending 31 March 2024.
